# Update from the Ontario Chamber of Commerce

## **ONTARIO EMERGENCY ORDER EXTENDED**

- Today, the Ontario government has extended all emergency orders in force under s.7.0.2 (4) of the *Emergency Management* and *Civil Protection Act* until **June 9**, **2020**. *Click here for a full list of extended emergency orders*.
- CANADA EMERGENCY COMMERCIAL RENTAL ASSISTANCE (CECRA)
  - The CECRA for small businesses application portal is open. <u>Apply here</u>.
  - Since the CECRA announcement, we have heard from numerous businesses that the program will not provide the support needed without improvements. The main concern is that commercial landlords may not participate in the program.

- We have called for the federal government to work with provinces and territories to address issues with the CECRA program, including improving the program uptake by landlords. Specifically calling for a "temporary" moratorium to allow for time for both landlords and tenants to digest the actual details of the rent subsidy program that only just launched on Monday.
- We appreciate how collaboratively the Ontario government has always worked with the Ontario business community. To stop widespread evictions & bankruptcies, we join the Canadian Federation of Independent Business, Ontario Chamber of Commerce, Ontario Restaurant Hotel & Motel Association, Restaurants Canada, and Retail Council of Canada in asking for a moratorium on commercial evictions. *See our announcement on social*.

#### Youth Employment And Skills Program (YESP) Enhancement

The Government of Canada is funding the YÈSP with up to an additional \$9.2 million to create up to 700 new positions for youth in the agriculture industry. This additional funding will help the agriculture industry attract Canadian youth, ages 15 to 30, to their organizations to assist with labour shortages brought on by the pandemic. This program aims to provide youth, and particularly youth facing barriers to employment, with job experience in agriculture that will provide career-related work experience. <u>More Information</u>

#### **Two New COVID-19 Funding Opportunities**

Innovation, Science and Economic Development Canada, through the Innovative Solutions Canada program, has two funding opportunities available. One seeks a smart digital exchange platform solution that will connect researchers, health providers and solution providers with the appropriate expertise, materials, devices and information to respond to COVID-19. The second requires a solution for reagents required for nucleic acid sample preparation and rapid and efficient SARS-CoV-2 Ribonucleic Acid (RNA) extraction in order to perform downstream molecular diagnostics of COVID-19 with capability to integrate within existing and/or potential microfluidic platforms for sample-to-answer solutions that can be deployed on the frontline for rapid testing. <u>More Information</u>

The CRA has extended deadlines for T2 Corporate Income Tax Returns and T3 Trust Income Tax Returns that had been due in June, July or August. Those returns are now due September 1, 2020. # **Update from the Federal Government**

Canada Emergency Wage Subsidy Consultation

On May 15<sup>th</sup>, we announced that after listening to Canadian business owners and entrepreneurs, <u>we extended</u> the Canada Emergency Wage Subsidy (CEWS) by an additional 12 weeks to August 29, 2020.

To continue to respond to the needs of Canadians, we <u>launched a consultation process</u> to seek information and feedback from businesses of all sizes, in every sector, labour representatives, not-for-profits, and charities on how the CEWS program can be adapted to save as many Canadian jobs as possible. All adjustments to the program, including the 30% revenue reduction threshold, are aimed to maximize employment, ensure the CEWS reflects the immediate needs of your business, and support the post-crisis economic recovery.

We want to hear from you. To participate in this consultation:

ii. Provide in-depth feedback to this email (fin.cews-succ.fin@canada.ca) using the guiding questions below:

- 1. Are there specific challenges associated with the CEWS program? For example, are there challenges with respect to its accessibility, its incentive impacts, or any other aspect?
- 2. What adjustments to the CEWS would you propose to provide the right level of support to those most affected by the pandemic while supporting the economic recovery?
- 3. Would adding complexity to the CEWS program be acceptable in order to expand access to this support, or better target support to those who need it?
- 4. To what extent are employers using the CEWS to provide support to furloughed employees as compared to using it as a means to pay active employees? Do employers value maintaining ties with furloughed employees by keeping them on the payroll? Should the level of support for furloughed employees be the same as for active employees?
- 5. What are the key barriers to rehiring workers recently laid off due to the pandemic?
- 6. Are there specific factors that are preventing or discouraging employers from applying for the CEWS?
- 7. If you are a seasonal business, are there any unique challenges you are facing in relation to the CEWS?

The consultations will close on June 5, 2020.
